## 4. First aid measures

### Description of necessary first aid measures

## 5. Fire-fighting measures

- Specific hazards arising from the chemical** : Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. ## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

## 6. Accidental release measures

## 8. Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation.
