## SECTION 4: First aid measures

4.1 Description of first aid measures

**Inhalation:** No known effects or symptoms in normal use.

Ingestion: Ingestion will lead to a strong caustic effect on mouth and throat and to the danger of perforation of

oesophagus and stomach.
