## SECTION 4: First aid measures

### 4.1 Description of first aid measures

<b>Inhalation:</b>	Remove person to fresh air and keep comfortable for breathing. Call a POISON CENTRE, doctor or physician if you feel unwell.

## SECTION 5: Firefighting measures
