SECTION 4: First aid measures

4.1 Description of first aid measures

General Information:

Symptoms of intoxication may even occur after several hours. It is recommended to continue medical observation for at least 48 hours after the incident. If unconscious place in recovery position and seek medical advice. Provide fresh air. If breathing is irregular or stopped, administer artificial respiration. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator. Remove person to fresh air and keep comfortable for breathing. Immediately call a POISON

Skin contact: Wash skin with plenty of lukewarm, gently flowing water for at least 30 minutes. Take off

immediately all contaminated clothing and wash it before reuse. Immediately call a POISON

CENTRE, doctor or physician.

Eye contact: Hold eyelids apart and flush eyes with plenty of lukewarm water for at least 15 minutes. Remove

contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE,

doctor or physician.

Ingestion: Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious

person. Do NOT induce vomiting. Keep at rest. Immediately call a POISON CENTRE, doctor or

physician.

Self-protection of first aider: Consider personal protective equipment as indicated in subsection 8.2.

4.2 Most important symptoms and effects, both acute and delayed

Inhalation: Corrosive to the respiratory tract.

Skin contact: Causes severe burns.

Eye contact: Causes severe or permanent damage.

Ingestion: Ingestion will lead to a strong caustic effect on mouth and throat and to the danger of perforation of

oesophagus and stomach.

4.3 Indication of any immediate medical attention and special treatment needed

No information available on clinical testing and medical monitoring. Specific toxicological information on substances, if available, can be found in section 11.

SECTION 5: Firefighting measures

5.1 Extinguishing media

Carbon dioxide. Dry powder. Water spray jet. Fight larger fires with water spray jet or alcohol-resistant foam.

5.2 Special hazards arising from the substance or mixture

No special hazards known.

5.3 Advice for firefighters

As in any fire, wear self contained breathing apparatus and suitable protective clothing including gloves and eye/face protection.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Do not breathe dust or vapour. Wear suitable protective clothing. Wear eye/face protection. Wear suitable gloves.

Dilute with plenty of water. Do not allow to enter drainage system, surface or ground water. Do not allow to enter the ground/soil. Inform responsible authorities in case undiluted product reaches drainage system, surface or ground water or the ground/soil.

6.3 Methods and material for containment and cleaning up

Ensure adequate ventilation. Dyke to collect large liquid spills. Absorb onto dry sand or similar inert material. Do not use fabric, sawdust, paper or other inflammable materials (danger of spontaneous combustion). Do not place spilled materials back into the original container. Collect in closed and suitable containers for disposal.
